Title:	Award of Contract 23-PW-007 – Milling of Asphalt,	Grading, Hot Mix Paving and
Miscel	laneous Concrete & Rehabilitation	

Recommendation: THAT Council of the Corporation of the Town of Smiths Falls pass a Bylaw to award Contract 23-PW-007 for Milling of Asphalt, Grading, Hot Mix Paving and Miscellaneous Concrete & Rehabilitation to Thomas Cavanagh Construction Limited;

AND FURTHER THAT Council authorizes the Mayor and the Clerk to executive a contract agreement with Thomas Cavanagh Construction Limited for the amount of \$869,595.45 (excluding HST).

**Purpose:** The purpose of this report is to provide background on the tender process for the annual Milling of Asphalt, Grading, Hot Mix Paving and Miscellaneous Concrete & Rehabilitation capital project and to award the contract to the lowest qualifying bidder.

**Background:** Proposed works specified within the tender documents will result in the rehabilitation of roadways and asphalt surfaces, vertical adjustment of existing appurtenances (maintenance hole frames and covers, water valve boxes), replacement and/or installation of new concrete curbing and sidewalks and minor landscaping reinstatement in the following locations;

Alfred Street – 10 m east of Lombard Street to 10 m west of Abbott Street	Full removal of existing road base and asphalt, new granular road base, concrete repairs and improvements including new 1.5 m sidewalk on the north side, vertical adjustment of appurtenances, new base and surface course asphalt, landscaping reinstatement	\$237,174.22
Chambers Street – Running Avenue to Rideau Avenue North and Rideau Avenue North from Chambers Street to Dufferin Street	Full removal of existing asphalt, concrete repairs and improvements, vertical adjustment of appurtenances, new base and surface course asphalt	\$219,459.13
Chambers Street – Running Avenue to Chambers Street dead end	Base and surface course asphalt paving, vertical adjustment of appurtenances	\$25,933.36
William Street East – Victoria Avenue to Sussex Street	Concrete curb and sidewalk improvements for pedestrian rail crossing, landscaping reinstatement TOTAL	\$53,743.27 \$869,595.45

Terms of the contract require that all works be completed on or before September 30, 2023.

The public tender closed on June 15, 2023 at 11:00 am. The Town received a total of three (3) tender submissions.

**NOTE:** Town staff have completed arithmetic checks on all bids. Where discrepancies were found the total bid prices were recalculated with the unit prices taking precedence.

The adjusted (final) tender prices are as follows;

Town staff have reviewed all three (3) of the tender submissions for accuracy and completeness and were otherwise found to be compliant with the Town's procurement bylaw.

**Analysis and Options**: Thomas Cavanagh Construction Limited had the lowest bid submission. The following options are presented for consideration;

**Option 1 (recommended) –** Award the contract to Thomas Cavanagh Construction Limited as they were the lowest tender and have the ability and resources to complete the works.

**Option 2 (not recommended) –** Do not award the contract to the lowest bid and consider one of the other higher bid submissions.

**Budget/Financial Implications:** There is \$812,376.00 approved in the 2023 Capital budget under the project description of Asphalt, concrete paving and milling program as well as \$57,200.00 under the description Railway crossing sidewalk at William/Sussex for a total of \$869,576.00 to fund this work. The total bid price inclusive of net HST (1.76%) is \$884,900.33. The balance of \$15,324.33 is recommended to be expensed from capital reserves.
