1. LAND ACKNOWLEDGEMENT

This land is the ancestral and unceded territory of the Algonquin Anishinaabe Nation. 10. PRIORITY ISSUES/REPORT

10.1 Section 357 Taxes Report 2023-104 (M Baumann)

As per Section 357 of the Municipal Act, upon application to the Treasurer, a local municipality may cancel, reduce, or refund all or part of the taxes levied on land in the year in respect of which the application is made. Two applications have been received:

- 1. 18 William Street
- 2. 31 Thomas Street

The total reduction in municipal property taxes stemming from these changes is \$6,397.24 for 2022 and 2023. There are monies in the 2023 approved budget to accommodate these write-offs.

10.2 Lease Agreement for Victoria Park Cantina Report 2023-98 (J Crowder) Staff have worked with Parks Canada to gain approval for the proposed seasonal self-contained mobile cantina to be operate within the Town's leased area in Victoria Park by the Chamber of Commerce. A Lease agreement has been drafted to set out terms related to the food service operations and to outline fees related to land lease and utility usage.

10.3 Appointment of New Municipal Law Enforcement Officer Report 2023-**105** (R Chesebrough)

R Chesebrough updated Council on the recruitment of a second By-law Enforcement Officer and sought approval to bring forward a By-law to officially appoint Sierra Swindells as a By-law Enforcement Officer for the Town of Smiths Falls.

10.4 Compensation Review Award of RFP Report 2023-107 (M Morris) M Morris offered that the purpose of the report was to provide Council with

the results of the Request for Proposal for the Pay Equity Program and Compensation Review and to award the work to the highest scoring proponent. M Morris advised that tis review is for Non-Union positions only as the other negotiating groups review positions during negotiations. Staff recommend that Council award the RFP to Gallagher Benefit Services Group Inc. The fee proposal from Gallagher is \$29,965 exclusive of HST. An amount of \$40,000 has been included in the 2023 budget.

10.5 Re-appointment of Source Water Protection Committee Member Report 2023-104 (M Morris)

M Morris advised that it is being recommended that Council endorse the reappointment of Diane Smithson to the Source Water Protection Committee as the municipal surface water member on behalf of the Town of Smiths Falls for the next 5-year term. Reviewed the report. Diane Smithson. Appointments to the Committee must be chosen from a list of names jointly submitted by the municipal councils within the group. The Surface Water group is comprised of Smiths Falls, the Town of Perth and the Town of Carleton Place (all of whom has confirmed support for D Smithson's re-appointment).






