# 5. PRIORITY ISSUES

i.) Consultant – Scope of Work M2 & M3

The group discussed whether a consultant is needed to determine what our current emissions are, what our emissions reduction targets should be, and how to track our progress. It was decided that because staff do not have the expertise or capacity to make a reasonable attempt at establishing these parameters, that a consultant would be helpful. Further, that a qualified consultant will have the expertise to help guide us towards targets and actions to reduce emissions and leverage our assets to get us where we need to be.

During this discussion, the committee members asked if the climate lens tool was being used by all staff when purchasing or making decisions. The group was informed that it is not being used for various reasons. There are two climate lens tools; a larger tool available on the federal website that is designed for use for major projects or purchases (millions of dollars). The second is a smaller scale tool that is in use by various municipalities. The group decided on the following motion:

#### MOTION:

"THAT, in consultation with other municipalities in Lanark County, staff prepare a draft climate lens tool use policy, for review by the Climate Protection Working Group Committee.

AND, that the draft policy should include a scoring mechanism."

# ii.) C.A.P. Update

R. Grant reviewed his report.

The recording structure of what the emissions are should be kept simple and consistent. For example, record the cost and the amount of greenhouse gas emissions only, and be specific. The group discussed possible guiding principles and equity. The different scenarios to use should be based on sewage treatment, trees, biochar, and food hub. These will be the best 4 to start with as they will be the lion's share of what the town can do to reduce emissions. Biochar was discussed as perhaps the best way to reduce emissions.
