Canadian Alliance to End Homelessness-Encampments

AND THAT encampments can only be effectively resolved through a housingfocused response, working hand-in-hand with those affected to find solutions that meet their needs.

NOW THEREFORE BE IT RESOLVED that the Council of the Corporation of the Town of Smiths Falls opposes Premier Ford utilizing the notwithstanding clause to dissolve encampments in Ontario.
